STATEMENT OF NO CONFIDENCE in the US Executive Branch 2025

We the undersigned declare our condemnation of the erratic actions of US president Donald J. Trump. We submit the following 50 items from the first six months of his 4-year term, that erode our confidence.

International Policy Actions

- 1. Threaten to invade Greenland, annex BFF Canada
- 2. Antagonize trade partners with (145%) yo-yo tariffs
- 3. Ambush foreign dignitaries in front of the press
